5. How does the peacemaker meet the criterion of being **locally based**? How long has she/he lived and worked in this locale? How does she/he work with the local community? *250 word limit*

6. How has the peacemaker received promotion and/or support? What awards has the peacemaker received? (Note that this award is not intended for individuals who have already been fortunate to receive extensive promotion and support.) *250 word limit*
