

2021 Religious Diversity Leadership Summit

Tanenbaum's 5th annual Summit went virtual for the first time, featuring online sessions held across multiple weeks. This year's theme was Do the Work: Build a Bigger Table. CEO Mark Fowler opened the Summit on May 4th welcoming keynote speaker Sarah Eagle Heart (Oglala Lakota) of Return to the Heart Foundation. The following week Tanenbaum's Manager of Programs Melinda Zalma opened the session "Purposeful Conversations: Lessons from Tanenbaum's Peacemakers for the Workplace."

On May 18th, an engaging moderated panel entitled "Women of Faith and Belief" representing multiple faith traditions and industries shared experiences and insights for all. The following week Tanenbaum welcomed Conrad Hackett and Samirah Majumdar from Pew Research Center to speak on global religious data and religious restrictions. CEO Mark Fowler closed the Summit on with a Learning Lab on June 3rd, hours before Tanenbaum's annual gala.




Tanenbaum's Peace Made Possible Gala!
