

DURING THE 2024-2025 SCHOOL YEAR, WE TRAINED APPROXIMATELY 300 TEACHERS IN THE NEW YORK CITY PUBLIC SCHOOL SYSTEM AND 250 FACULTY, STAFF, AND COMMUNITY MEMBERS AT A NEW YORK CITY INDEPENDENT SCHOOL. IN FEBRUARY 2025 THE EDUCATION PROGRAM CONCLUDED A 3-YEAR CONSULTING COLLABORATION WITH CHILDREN'S MUSEUM HOUSTON. MEMBERS OF THE 2024-2025 TANENBAUM EDUCATION ADVISORY BOARD WORK WITH OVER 1,000 STUDENTS NATIONWIDE, INCLUDING IN NEW YORK CITY, RALEIGH, NORTH CAROLINA; SEATTLE, WASHINGTON; ATLANTA, GEORGIA; HUDSON, OHIO; AND NEWTON, NEW JERSEY.

THE WORKPLACE PROGRAM ENGAGES BUSINESS LEADERS, GLOBAL EMPLOYERS, MANAGERS, AND DEI AND HUMAN RESOURCES PROFESSIONALS TO COUNTER HARASSMENT AND DISCRIMINATION AND BUILD RELIGIOUSLY INCLUSIVE WORKPLACES. THROUGH TRAININGS AND MATERIALS ON HOW TO EFFECTIVELY WORK WITH A GLOBAL AND INCREASINGLY RELIGIOUSLY DIVERSE WORKFORCE AND CUSTOMER BASE, COMPANIES IMPROVE THE BOTTOM LINE AND BECOME MORE PRODUCTIVE AND INCLUSIVE ENVIRONMENTS. IN 2024, WE HOSTED THE 8TH ANNUAL SUMMIT ON MAY 8TH, 2024 WITH 252 TOTAL ATTENDEES (98 IN-PERSON, 154 ONLINE) AND ANNUAL EXECUTIVE-LEVEL SYMPOSIUM ON OCTOBER 29TH, 2024 WITH 83 TOTAL (47 IN-PERSON, 36 VIRTUAL). THE WORKPLACE TEAM AND LEADERSHIP CONDUCTED OVER 70 TRAININGS REACHING OVER 11,000 PEOPLE. THE HEALTH CARE PROGRAM BUILDS HEALTH CARE PROVIDERS' CAPACITY FOR OFFERING RELIGIOUSLY COMPETENT HEALTH CARE AND THEREBY PREVENTING DISPARITIES IN TREATMENT. TANENBAUM INVESTS IN THE FUTURE OF HEALTH CARE WITH TARGETED TRAININGS, E-LEARNING, AND BY DISSEMINATING CURRICULUM TO MEDICAL SCHOOLS, RESIDENCY PROGRAMS, AND NURSING SCHOOLS TO PREPARE THE NEXT GENERATION OF MEDICAL PROVIDERS FOR AN INCREASINGLY RELIGIOUSLY DIVERSE PATIENT POPULATION. TANENBAUM TO BUILD A SAFER, MORE EQUITABLE WORLD FOR PEOPLE OF ALL BELIEF SYSTEMS. TODAY, RABBI TANENBAUM'S LONGTIME SCHOLARLY PARTNER, DR. JUDITH BANKI CONTINUES THE RESEARCH, ANALYSIS, AND DIALOGUE THAT WAS SUCH AN IMPORTANT PART OF RABBI TANENBAUM'S LEGACY.
